IF IN EYES:

- Hold eye open and rinse slowly and gently with water for 15-20 minutes.
- Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes.

- Have person sip a glass of water if able to swallow.

- Discontinue use.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

This product provides up to 8 hours of protection from Mosquitoes and up to 4 hours protection from Black Flies, Stable Flies, Sand Flies, Gnats, Chiggers, Fleas, and Ticks. Convenient, easy to use pump spray allows quick and thorough application to skin, hair, and clothing for maximum protection.

Read and follow all directions and precautions on this product label. Do not apply over cuts, wounds, or irritated skin. Do not apply to eyes and mouth. Apply sparingly around ears. Do not apply to children's hands. Do not allow children to handle this product. When using on children, apply to your own hands and then put it on the child. Use just enough repellent to cover exposed skin and/or clothing. Do not use under clothing. Avoid overapplication of this product. After returning indoors, wash treated skin with soap and water. Wash treated clothing before wearing it again. Use of this product may cause skin reactions in rare cases. If you suspect that you or your child is reacting to this product, wash treated skin and call your local Poison Control Center. If you go to a doctor, take this repellent product with you.

Hold container upright about 4 to 6 inches from skin or clothing. Do not spray in enclosed areas. If used on face, spray on hands first and then apply sparingly and avoid eyes. Do not spray directly onto face. Do not use as a space spray. Spray and spread evenly with your hand to moisten all exposed skin. Also, apply to clothing such as shirt, pants, hat, and socks. Frequent reapplication and saturation of clothing are unnecessary for effectiveness. For Chiggers and Ticks, apply to shirt and pant cuffs and socks.

NOTE: Will not damage cotton, wool, or nylon. Do not apply on or near acetate, rayon, Spandex or synthetic fabrics, nylon furniture, plastics, watch crystals, leather and painted or varnished surfaces (including automobiles).

STORAGE AND DISPOSAL

PESTICIDE STORAGE: Store in a cool, dry place. Keep container closed.
PESTICIDE DISPOSAL AND CONTAINER HANDLING: Nonrefillable container. Do not reuse this container. **If Empty:** Place in trash or offer for recycling if available. **If partly filled:** Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.
